ORDINANCE NO. 2021- ____**

**AN ORDINANCE OF EAST BRADFORD TOWNSHIP, CHESTER COUNTY,
PENNSYLVANIA, AMENDING THE EAST BRADFORD TOWNSHIP CODE BY
INCREASING THE RATE OF COMPENSATION FOR THE BOARD OF
SUPERVISORS AS THE POPULATION IN EAST BRADFORD TOWNSHIP IS
NOW IN THE 10,000 TO 14,999 RANGE**

WHEREAS the Second Class Township Code (the "Code") sets forth certain guidelines and limitations for the compensation of supervisors of township of the second class, 53 P.S. §65606, and

WHEREAS said Code provides the supervisors of township having a population of 10,000 to 14,999 shall be compensated in an amount not to exceed \$3,250 annually, and

WHEREAS the population of East Bradford Township is 10,339 per the official 2020 Census.

WHEREAS the Code authorizes the boards of supervisors of the various townships of the second class to determine the compensation of supervisors subject to the limitations set forth in the Code.

BE IT ORDAINED AND ENACTED by the East Bradford Township, Chester County, PA, Board of Supervisors and it is hereby enacted and ordained by authority of the same.

SECTION 1. Each supervisor of East Bradford Township whose term of office starts on or after the effective date of this Ordinance shall receive compensation as a supervisor in the annual amount of \$3,250.

SECTION 2. Such compensation shall be paid in quarterly installments.

SECTION 3. The effective date of this Ordinance shall be December 31, 2021.
